5.2 2021 MRCC By-law Updates

- Standardize on date format of xx/xx/xxxx. During past edits, this was not consistent. Or... Possibly eliminate the old edit dates.
- Make July meeting optional. All but one of the replies I received wanted to cancel this
 meeting. (Mark had canceled a July meeting in the past.) But, the current by-laws says
 we must have the meeting.
- Add provision for in-person and electronic (Zoom) combination meeting format. The
 intention is to use the recent vote as the guide. Possibly we could require approving
 this for every year. Currently I am thinking that the board should (shall?) be in person
 while others can optionally be via Zoom.
- Add provision for RE to cancel a meeting or go to an all-electronic meeting during special circumstances. Examples are a pandemic, national emergency, government order, etc. This should address what we just went through.
- Add provision for electronic voting. This may require a roll-call vote.
- Add provision for electronic nominations. This may be required if a meeting is canceled.
 For example, round 1 of officer nominations if the July meeting is canceled or Trails
 Committee nominations if the November meeting is canceled.

- Add section for storage, check-in, and check-out of bylaws. The master copy should be kept by the Secretary and a non-editable copy should be provided to the Webmaster for posting on the website.
- Suggestions: Show changes to by-laws in a red line version, possibly making a history page for changes.
- A By-law Update committee was formed: George Duncan, chairperson, Mark Hanlin and Kyle Felts.
