- When entering new members please make sure their information is correct and that couples are linked.
- There is a lot of interest in becoming a Lifetime member! When entering Lifetime members, you can change their Member Type to "Renew as Lifetime" and it will show they owe \$335. Send a screenshot to me and I have to correct that amount to \$300, reset the renewal code and status, thus generating a Control Sheet. Once the club "Submits to RMD", provides you with a check, you've accepted it on the Control sheet, a deposit is made, a transaction report will show the correct payment.
