- I've updated the website with upcoming events. I have added contact info for
 Westshore Corvettes and will update their info once their logo has been approved and
 their website goes live. As a reminder, I can build a freestanding page, hosted on the
 Region site, for any club that doesn't currently have their own website. Just send me
 the info you would like included.
- Kyle Felts informed me that the links on NCCC's "Find a Club" page were still pointing to the former Region web address. I forwarded the information to Walt Jenkins and he corrected it immediately.
- I ran a 12-month web analytics report for micorvette.org today. Since September 9, 2024, we've had 8,919 visitors with an average duration of 99 seconds. The most popular web browsers used were Chrome with 2,764 visits; Edge with 1,811 visits; Safari with 729 visits; and Firefox with 161 visits. Mobile phone visits included 2,318 using Apple IOS devices; and 985 using Android devices. Overall page visits included 4,610 to the "Home" page; 2,823 visits to "Event Flyers;" 1,832 visits to "Points Standings;" and 801 visits to the "Calendar."

- Chapter 12 Provisional Programs:
- Three programs drafted: Young Guns, FCOA, ZORA.
- Draft language complete and aligned with Chapter 12 format.
- Ready for national review.
- Drag Racing Rule Updates:
- Rewritten with AI assistance and committee review.
- Simplified structure, clearer classes, whole-number points.
- Bracket/index clarified, dyno references removed.
- Bonus/participation points capped fairly.

• Ready for competition committee presentation.

Autocross Classification Rewrite

- Old numeric/alphabetical classes replaced with Corvette generation designations (C1–C8).
- Easier for public and competitors to understand.
- Maintains technical accuracy; needs governor review for legacy data alignment.

• High Speed Program Updates

- C8 High Speed: addresses unique performance and safety of 8th-gen Corvette.
- C8 Post-Record Tech Inspection: ensures compliance after record runs; improves transparency.
- Draft language incorporated into high-speed section; ready for review.

• Safety Committee Updates

- Clarified course inspection responsibilities (RCD or designee).
- Updated worker guidelines (safety vests, corner visibility).
- Strengthened consistency between regional and national safety expectations.
- Drafts ready for committee review.
